Introduction

The primary objective of internal audit is to review, appraise and report upon the adequacy of internal control systems operating throughout the council. To achieve this SALC adopt a predominantly systems-based approach to audit.

The council's internal control system comprises the whole network of systems established within the council to provide reasonable assurance that the council's objectives will be achieved, with reference to:

- the effectiveness of operations
- the economic and efficient use of resources
- compliance with applicable policies, procedures, laws, and regulations
- the safeguarding of assets and interests from losses of all kinds, including those arising from fraud, irregularity, and corruption
- the integrity and reliability of information, accounts, and data



Methodology

When conducting the audit, the internal auditor may:

- conduct a selective assessment of compliance with relevant procedures and controls expected to be in operation during the financial year in order to be able to complete the Annual Internal Audit Report 2022/23 of the Annual Governance and Accountability Return (AGAR)
- review the reliability and integrity of financial information and the means used to identify, measure, classify and report such information
- review the means of safeguarding assets and, as appropriate, verify the existence of such assets
- appraise the economy and efficiency with which resources are employed, identify opportunities to improve performance and recommend solutions to problems
- review the established systems to ensure compliance with those policies, procedures, laws, and regulations which could have a significant impact on operations, and determine whether the council complies
- review the operations and activities to ascertain whether results are consistent with objectives and whether they are being conducted as planned

Council has elected to report its financial matters on a receipts and payments basis.		
Is the cash book up to date and regularly verified?	Yes	The cashbook is reconciled on a regular basis. Council follows proper practices in ensuring that there are clear financial management reports submitted to the council on a regular basis.		
Is the arithmetic correct? Yes		A number of spot checks were conducted, and the functionality of the cashbook was found to be in order.

Vas	statutory requirements) to ensure that they are relevant to the Parish Council, they do not contain up to date financial thresholds. Recommendation: council is advised to review the Procurement Thresholds amendments (SI 2022/139) of the Public Contracts (Amendment) Regulations 2022 which came into force on 21 st December 2022 (see below) and ensure that the updated figures are incorporated into Standing Order 18av and 18c. Financial Regulations (FR), as seen on the Council's website were also
765	reviewed at the meeting in October 2023 and are based on the NALC Model Financial Regulations 2019. Council has not updated the FRs with the amended values for contracts as outlined under LTN 87 - Procurement – March 2022. Recommendation: SALC have advised (07.05.24) that the revised model Financial Regulations have now been published by NALC for use by councils and include the amended thresholds for procurement. It is these FRs which should be adopted by council at the earliest opportunity.

Yes	The risk assessment documentation as reviewed provides details of the risks associated with the functioning of a smaller authority and the measures that the Council will undertake to mitigate such risks. The Risk Register for the year under review was considered and adopted by the council at its meeting of 9 th May 2023 for the year ending 31 st March 2024.
Is there evidence that risks are being identified and managed?	Yes	Council is aware that risk assessment needs to focus on the safety of the parish council's assets, operations and in particular its money. There is evidence that overall the parish council has taken action to identify and assess those risks and has considered what actions or decisions it needs to take during the year to manage in order to avoid financial or reputational consequences.
Does the Council have appropriate and adequate insurance cover in place for employment, public liability and fidelity guarantee and has been reviewed on an annual basis?	Yes	Council has insurance in place under a Local Councils Policy with Clear Councils as underwritten by Aviva Insurance which shows core cover for the following: Public/Products Liability: £10million; Employer's Liability £10million and Fidelity Guarantee of £50thousand. Comment: Council has followed recommended guidance by ensuring that its Fidelity Cover is equal to at least the sum of the year-end balances plus 50% of the precept/grants to be received in the following April/May. There is no minute reference to demonstrate that Council, being aware that it is the responsibility of the Council as a whole to satisfy itself that insurances



		are adequate and that all steps have been taken to mitigate and manage identified risks with appropriate insurance, undertook an annual review of the Council's insurance prior to renewal. The minutes of the meeting of 6 th September 2023 merely indicate that council approved the payment to renew the insurance. Comment: Council should seek to provide evidence that it is able to demonstrate that it has reviewed the risks facing the Council in transacting its business and has taken out appropriate insurance to manage and reduce the risks relating to property, cash and legal liability (amongst other things). A minute reference would provide evidence that council has reviewed the levels of insurance for land, public and employees liability against quotations received and the cover being proposed and agreed to renew with the current insurers.
Evidence that internal controls are documented and regularly reviewed ⁴	Yes	At the meeting of 9 th May 2023, Council, in accordance with Regulation 6 of the Accounts and Audit Regulations 2015, confirmed that the financial and management systems of the council were sound and adequate and internal control arrangements were efficient and effective to address the risks associated with the management of public finances. Such evidence is contained within the Internal Control Statement as adopted by the parish council. Comment: Council shows good practice of appointing a councillor(s) to review the system of internal control via specific tests and as such has demonstrated that it has understood the requirements to have in place safe and efficient arrangements to safeguard public money.
Evidence that a review of the effectiveness of internal audit was conducted during the year, including consideration of the independence and competence of the internal auditor prior to their appointment ⁵	Yes	The minutes of 11 th July 2023 demonstrate that the council formally reviewed the scope and effectiveness of its internal audit arrangements and concluded that the standards were being met and that the work of internal audit was effective. It is also noted that this is evidenced in the Internal Control Statement adopted by the council. Comment: Council is aware that in accordance with the Accounts and Audit Regulation 2015, it must review the terms of reference and effectiveness of internal audit and demonstrate that it has understood that the role of internal

Verify that budget has been properly prepared and agreed	Yes	The budget for the year 2023-2024 was approved at the Council meeting of 12 th January however there is no reference to the amount set within the minutes. From paperwork seen on the website, and as submitted as an associated paper to the meeting, a revenue budget was set in the sum of £5,495. The budget for the year 2024-2025 was approved at the council meeting of 10 th January 2024 and set at £6,180 as per paperwork seen on the website. Comment: council is advised to ensure transparency in the budgetary process followed by the council by recording within the minutes the actual budget being set alongside the reasoning for such a budget.
Verify that the precept amount has been agreed in full Council and clearly minuted	Yes	The precept for the year 2023 – 2024 was set at £5,200 at the meeting of 12 th January 2023 with the details demonstrating that this was an increase of £0.76 or 1.77% on that set for the previous year. The precept for the year 2024 – 2025 was discussed and approved at the meeting of 10 th January 2024 and set at £6,100. There is no indication as to the impact that this would have on a Band D Dwelling.
Regular reporting of expenditure and variances from budget	Yes	Council continues with the practice of a written report being submitted on a quarterly basis showing current bank balances along with aggregate receipts and payments and variance against budget. Comment: Council, in accordance with its own standing order 17c, produces regular statements showing evidence of comparisons between budgeted and

There is no upper limit for earmarked reserves, but they should be held for genuine and intended purposes and their level subject to regular review and justification (at least annually). Yes	All salary payments are presented to full Council for approval and payment is made via internet banking in accordance with council's own Financial Regulations. Amendments to salary points are all approved by full council. Comment: Council ensures that there are suitable payroll arrangements in place which ensures the accuracy and legitimacy of payments of salaries and wages, and associated liabilities and as such the council has complied with its duties under legislation.
Minimum wage paid?	No	No employee is paid the national minimum wage.
Are arrangements in place for authorising of the payroll and payments to the council?	Yes	There are suitable payroll arrangements in place which ensures the accuracy and legitimacy of payments of salaries and wages, and associated liabilities and as such the council has complied with its duties under legislation.
Do salary payments include deductions for PAYE/NIC? Is PAYE/NIC paid promptly to HMRC?	Yes	The payroll function for the year under review is operated in accordance with HM Revenue and Customs guidelines. Cross-checks were completed on a sample of payments covering salary and PAYE were found to be in order. A clear audit trail should be available when items are purchased including minutes to evidence approval.

Evidence Does the Council maintain a register of material assets it owns and manage this in accordance with proper practices? 9	Yes	Internal auditor commentary The Asset Register, as viewed on the Council's website, was reviewed during the Internal Audit Visit for year-end and reflects those items listed under insurance and within the Parish Council's remit for maintenance and ownership. It is noted that the declared value for all assets at year-end (31.03.2024) is £54,037, which reflects no movement in the asset register since that declared at 31 st March 2023.
Is the value of the assets included? (Note value for insurance purposes may differ)	Yes	Council is mindful of the guidance within the Governance and Accountability for Smaller Authorities in England March 2023 on the valuation of its assets and has ensured that where the acquisition value of the asset at the time of first recording is used, that method of valuation has been consistently applied.
Are records of deeds, articles, land registry title number available?	Yes	Records of deeds, articles, land registry title number were not reviewed during the internal audit which was conducted via remote means.
Are copies of licences or leases available for assets sited at third party property?	N/A	Council does not have any assets located on third party property.
